Lead and Copper Monitoring Requirements

Were met late for Pioneer Elementary School Water During Calendar Year 2024

Our water system failed to monitor in the appropriate time frame as required for drinking water standards during 2024 and, therefore was in violation of the regulations. Although this is not an emergency, as our customers, you have a right to know what happened, what you should do, and what we did to correct the situation.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During calendar year 2024, we did not collect Lead and Copper samples in a timely manner. We were required to collect the samples between June 1 and September 30, 2024. We did not collect the samples until November 17, 2024.

What should I do?

- There is nothing you need to do at this time.
- The table below lists the contaminant we did not properly test for during the calendar year 2024, how many samples we are required to take and how often, how many samples we took, when samples should have been taken, and the date on which follow-up samples will be taken.

Lead and Copper	A set of 10 tap water samples triennially	10 samples were collected after the required monitoring period.	During Calendar Year 2024 between June 1 and September 30.	We collected the samples on November 17, 2024.

What happened? What is being done to correct the missed sampling? We forgot to collect the samples during the required time period, but we did collect the samples on November 17, 2024. We will collect an additional set of 10 samples during the required period in 2025.
