2023-24 School Description and Mission Statement

Walt Tyler Elementary School opened as a Necessary Small School in November of 1997. The school property is located in the community of Grizzly Flats, 12 miles from the District's office and the District's two other schools. Its opening was the result of months of district and community planning. It currently serves transitional kindergarten through grade 3.

Walt Tyler is the proud recipient of the California Distinguished School Award for 2002. The school prides itself on its innovative education through the use of a multi-age approach to the curriculum. Decisions regarding programs offered and efforts at establishing a community of learners are guided by the overriding assumption that we are responsible for educating the whole child, not merely imparting information in the basic curricular areas.

Walt Tyler Elementary School was destroyed during the 2021 Caldor Fire along with many homes in Grizzly Flats. The Pioneer Union School District is actively working to rebuild. Students displaced from Walt Tyler School currently reside at Pioneer Elementary School. Information in the Walt Tyler School Accountability Report Card pertain to students enrolled in Walt Tyler Elementary School.
