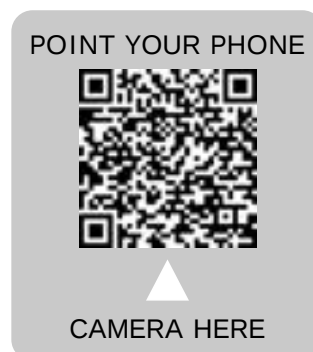

Superintendent Paturel reported we are on the fourth day of school today and it has been a very positive start.
