5.2 Correspondence received by the Board: Discussion: President Russell acknowledged the LCAP Approval letter from EDCOE. 5.3 Superintendent Report: Discussion: Superintendent Paturel reported the Board Member placemats have been updated. He also reported on October 2nd the teachers had a professional development day learning the new Star Math and Reading program. He reported those programs tie into the new Accelerated Reader program that is being launched in Kinder through 8th grade. Superintendent Paturel reported the cross country team hosted 4 schools plus our students here yesterday and finals will be held next week at the fairgrounds. He reported attendance is up from last year as of cnesus day. Lastly he reported he attended the CILC (Curriculum Instruction Leaders Council) meeting and their main focus is on attendance and EDCOE will be paying for Attendance Works so we can really look at attendance from month to month. 5.4 Principal Report: Discussion: Principal Holler reported the Star Assessment platform has really been powerful for the Pioneer teachers, it easilky allows them to identify students who need intervention services. He also reported teachers are getting excited about the Accelerated Reader program. Lastly he reported he is working with the teachers on the positive behaviour program where they are giving students tickets to reward positive behaviour and they can later redeem their tickets at the ticket store. Principal Paturel reported Mt. Creek has adjusted the library time this year so small groups of students can utilize the library and check out books. He also reported the middle school will be given 18 minutes every day for silent reading. Principal Paturel reported he has implemented extension oppurtunities to students with the first one being a math problem. Lastly he gave an update on the Bean Bag Bonaza competition that has started during lunch. 5.5 LCAP Report: Discussion: Superintendent Paturel had nothing new to report on the LCAP. 5.6 Budget Report: Discussion: CBO K. Howard reported she is currently watching bills that are on the governors desk and must be vetoed or signed by tomorrow. She reported all busses will need to be electric by 2035, this timeline will give districts of rural communities time to figure out logistics and charging facilites needed. CBO K. Howard reported attendance reporting is looking like it will be better at the first reporting requirement. Lastly she reported the cafeteria purchased a new car for their program since their van wnt down a year ago. 5.7 Maintenance and Operations Report: Discussion: CBO K. Howard reported an email was received from School Insurance Company stating they are wrapping up their assessment of the Walt Tyler rebuild project and would like to schedule a zoom soon. She reported the contract for the justified fees report has been signed. Mrs. Howard reported PG&E is installing the transfer switch this weekend for the generator that will be installed eventually. She also reported PG&E has is encouraging the district to apply for a \$50,000 grant to go towards the generator purchase. She reported the district will see a large cost for water testing coming up due to the many water samples that were due to be collected. Mrs. Howard reported the maintenance guys are still batteling water leaks around both campuses. Lastly she reported the maintenance department will be purchasing leaf/grass bag to be able to help with campus cleanup.
