We are pleased to inform you that Pioneer Union School District will be implementing a new option available to schools participating in the National School Lunch and School Breakfast Programs called the Community Eligibility Provision for the 2025 – 2026 School Year.

What does this mean for you and your children attending the school(s) identified above?

Great news for you and your students! All enrolled students of Pioneer Union School District are eligible to receive a healthy breakfast and lunch at school at **no charge** to your household each day of the 2025–2026 school year. No further action is required of you. Your child(ren) will be able to participate in these meal programs without having to pay a fee or apply.

But wait, there's more!

There are additional benefits for your family and our school if you do qualify under the Universal Benefits Application. You can receive extra funding over the summertime, and discounts on internet access. The school can receive necessary funding to keep programs like Intervention and Full-Day Preschool in place. We are attaching the application and qualifications to this letter. Please return it as soon as possible. The deadline is September 30th.
